

WKLB-FM Top 5 O'CLOCK RIDE Contest Rules

How to Enter for a Chance to Win

Listen to Country 102.5 WKLB-FM each weekday Monday through Friday between 5:00-6:00pm (ET) for Steve Kelly (or another Country 102.5 personality) to tell you to call in. The 25th caller to 1-888-819-1025, will win the prize (subject to confirmation of eligibility and completion of phone call). If the 25th caller does not correctly name the Top 5 for that day, WKLB will continue taking calls until there is a winner.

Online listeners to the Station web stream may experience a reception delay of up to one minute. Listening to the station's over-the-air broadcast is the best way to participate in this contest. Winner qualification is subject to FULL phone call completion, and the verification of the caller's name, address, home phone number, work/cell phone number and social security number, all of which must be provided prior to completion of the call. Contest calls will not be accepted at any other number.

Prize
