

WKLB-FM ON DEMAND LUNCH Contest Rules

How to Enter for a Chance to Win

Listen to Country 102.5 WKLB-FM each weekday Monday through Friday at approximately 12:50pm (ET) for Carolyn Kruse (or another Country 102.5 personality) to ask you to call in for your chance to win a treat for your lunchbox. The 25th caller to 1-888-819-1025 will win the prize (subject to confirmation of eligibility and completion of phone call).

Online listeners to the Station web stream may experience a reception delay of up to one minute. Listening to the station's over-the-air broadcast is the best way to participate in this contest. Winner qualification is subject to FULL phone call completion, and the verification of the caller's name, address, home phone number, work/cell phone number and social security number, all of which must be provided prior to completion of the call. Contest calls will not be accepted at any other number.

Prize
